

2019-2020 BUDGET

The school budget reflects our educational program in dollars. It is the basis for every phase of the district's operation - personnel, curriculum, buildings, instructional materials, equipment, transportation, after-school activities, etc. We face the same challenges that school districts across the state face — a 2% cap, enrollment changes, increases in health insurance premiums, utilities, textbooks and supplies, unfunded state mandates, and facilities maintenance.

The budget was carefully scrutinized for efficiency and effectiveness. All expenditures, existing and new, were carefully considered and any possible savings were explored. Once the budget is approved by the county, on behalf of the state, and adopted by the Board of Education, the total dollar amount budgeted for the year is set.

With the current total assessed value of properties in Washington Township, the 2019-2020 budget will raise the tax levy by 2.2534¢ per \$100 assessed value or about \$56 a year on the average Washington Township home.

- ★ Provides students with safe and secure facilities

- * Provides students with opportunities to explore their talents and interests, including co-curricular activities.

The 2019-2020 proposed budget:



State Aid History / Summary



As the state attempts to fully fund the flawed 2008 School Funding Reform Act, "adjustment aid" is being phased out in nearly 200 school districts. Since 2017 – 2018, Washington Township has lost \$315,670 in state aid. Unless the state changes the formula, adds funds or our enrollment increases, we expect additional decreases in state aid for another 5 years. The 2% tax levy increase of \$124,371 does not make up for this year's \$210,670 loss of state aid.

Through careful budgeting and planning, the district has been able to take a "pay as we go" approach to funding projects, equipment purchases and major maintenance concerns. Since 2006, including this budget, the district will have completed over 4.5 million dollars in capital improvements, maintenance projects and equipment purchases without taking on bond debt.

- \Rightarrow Capital projects including new windows at BC, office at PC, roofing, fire alarm systems, security upgrades, etc.
- ⇒ Maintenance projects including HVAC at BC & PC, paving, sidewalk repairs, asbestos removal, etc.
- ⇒ Equipment purchases including tractor for PC, fob (key) & phone system, computer servers, wireless access points, computers, classroom and library furniture, pick up truck, etc.)
