Dear Washington Township Families,

As we prepare components of the School Reopening Plan, we continue to share information with families to assist them with making a decision as to whether their student should participate in the in-person learning option or remote learning option.

To assist parents with this choice, we have provided the following draft schedules for remote learning (see below to access draft schedules). Please understand these are DRAFT schedules and are subject to change. We have developed these schedules to provide remote learning students opportunities to participate in live Microsoft Teams meetings with teachers/classes as well as opportunities to complete independent practice.

In general, the following guidelines would be in place for the remote learning option:

- Remote learning students would be required to sign in and take attendance each day.
- Students would be expected to participate in scheduled Microsoft Team meetings as set in their schedule.
- Students would be expected to complete assignments / projects as assigned by their remote learning teacher.
- Schedules and programs will be adjusted on an individual basis for students with special needs, 504 plans or other special programs.

We have provided this information to give families a feel for the type of programing/schedule a student can expect with regard to a remote learning option. Families are again reminded these documents are DRAFT schedules and are subject to change. The state has not released their requirements for Remote Learning Options as were expected. Also, the state has not released their checklist of School Reopening Plan requirements. Please keep in mind, these state regulations may significantly alter both Remote Learning and In-person school options.
