Contestant Qualifications:

1. Be a resident of Warren County for at least one year.
2. Be at least 6 years of age and not over 10, as of the date of competition.
3. All contestants will be required to participate in: (for any event you do not participate in that are required will result in points deducted from the final score)

Each contestant will be judged on:

1. Completion of application
2. Introduction and Stage presence
 - 2.1.Introduction

2.1.1. Should include Name, Town, Age, School, and community activities and accomplishments. What is your favorite part of the fair? No longer than 1 minute.

2.2. Appearance

2.2.1. Formal attire, only one outfit, there will be no changing. Other than talent

3. Talent

3.1. 5 minute maximum

3.2. Must bring all your own props and music for talent.

3.3. Parents are in charge of setting up and removing all props as quickly as possible.

3.3.1. All equipment should be brought to rehearsal.

- First runner up- \$75, tote bag
- Second runner up- \$50, tote bag
